- 4. The CGPA/Grade to % conversion formula (issued by competent authority) applicable for the degree awarding institution (wherever grading other than % is used) has to be submitted along with the application, if the formula is not already provided in the certificate/mark sheet.
- 5. Primary research publications will only be considered for evaluation. Review papers will not be considered.
- 6. Canvassing in any form is not permitted and any interim enquiry will not be entertained.
- 7. The position is purely temporary and coterminous with the project; and selection to the position will not entitle the candidate any claim for future positions (permanent or otherwise) at Institute of Advanced Virology or with the funding agency.
- 8. The selected candidates can be posted and are liable to work at any part of the country as per the project requirements.
- 9. The duration of the project is for five years. The performance of the selected candidates will be evaluated annually or at intervals fixed by the authorities; and the Institute reserves the right to decide on the continuation/termination of the appointment based on the performance.
- 10. The Director, IAV reserves the right to decide on any matter related to the selection procedure, including cancellation of the selection process, if circumstances demand so.
